IF WE DO SO, WE WILL CONTACT YOU BY EMAIL. IF YOU DO NOT WANT US TO USE YOUR DATA IN THIS WAY, PLEASE CONTACT US USING THE CONTACT DETAILS BELOW.
- 9. YOUR INFORMATION MAY BE USED BY US FOR THE PURPOSE OF RESEARCH AND STATISTICAL ANALYSIS AND INTERNAL CUSTOMER SERVICE MONITORING.

- 12. WE MAY DISCLOSE YOUR PERSONAL DATA TO THIRD PARTIES IF WE ARE UNDER A DUTY TO DISCLOSE OR SHARE YOUR PERSONAL DATA IN ORDER TO COMPLY WITH ANY LEGAL OBLIGATION, OR IF WE REASONABLY BELIEVE THAT DISCLOSURE OF YOUR PERSONAL DATA TO THIRD PARTIES IS NECESSARY IN ORDER TO ENFORCE AN AGREEMENTS; OR TO PROTECT OUR RIGHTS, PROPERTY, OR SAFETY OR THAT OF OUR USERS, OR OTHERS. IF OUR BUSINESS IS SOLD YOUR DETAILS WILL BE PASSED ONTO THE NEW OWNERS OF THE BUSINESS.
- 15. WE MAY EMPLOY THE SERVICES OF OTHER PARTIES FOR DEALING WITH VARIOUS MATTERS IN CONNECTION WITH OUR SITE AND THE SERVICES PROVIDED ON OUR SITE. THE PROVIDERS OF SUCH SERVICES MAY HAVE ACCESS TO YOUR PERSONAL DATA.
